134th running of the VELKA PARDUBICKA with SLAVIA INSURANCE

Crosscountry steeplechase Listed 6900 m CZK 5.000.000

CZK 5.000.000 (2.000.000 – 1.100.000 – 700.000 – 500.000 – 350.000 – 200.000 – 150.000)

For 6-y-o and older horses which have fulfilled the following qualifying conditions: Horses must have completed at least one qualification race in 2024. The qualification races are races Nos. 040301, 040401, 040501 and 040701 at Pardubice racecourse. A condition for qualification is to be placed in the first five finishers, or to finish the race within 20 seconds of the winner. In the case that there is a small number of qualified horses, the organiser reserves the right to extend the qualification time. Qualification can also be achieved by completing a race in the Crystal Cup series, or a steeplechase, a cross-country steeplechase or a cross-country race over a distance of at least 4 800 metres in Ireland, the United Kingdom, France or Italy, held after October 9th, 2023. The winner of the 133rd Velka Pardubicka has the right to run without pre-qualifying.

It is a condition for the participation of a rider that she/he must have ridden at least 10 winners over fences in her/his career and must have finished at least one steeplechase or cross-country steeplechase in 2024, or alternatively must have been placed at least 10 times in races over fences in her/his career and must have completed at least one qualification race for the Velka Pardubicka in 2024.

Weight: 70 kg. Mares receive an allowance of 2 kg.

The ceremonial announcement after the race will be attended by the owner, the trainer and the rider of the winning horse and also by the riders of the horses placed 2nd – 7th.

All runners must participate in the private veterinary inspection without announcements on October 13, 2024. The inspection will take place from 8.30 a.m. until 9.00 a.m. in the stables area.

All runners must participate in the parade in front of the main stand.

All riders are required to wear the jacket and the cap of the sponsor.
